- The regional centre/organizer to make all the necessary arrangements as per approved norms/approved by competent authority, for the camp sanctioned.
- Facial attendance in the national coaching camp is mandatory. Regional centre/head coach attached with the team is requested to ensure the facial attendance of all the campers.

- 9. Medical insurance to be done through SAI head Quarters, New Delhi.
