 4. Any inclusion/deletion of National Coaching Campers should not be entertained without prior approval of the TEAMS Division.
 5. On conclusion of the Coaching Camp Regional Center shall submit a report on coaching camp within 10 days to the TEAMS Division, New Delhi.
 6. The Regional Center/Organizer to make all the necessary arrangements as per approved norms/approved by Competent Authority, for the camp sanctioned.
 7. Facial attendance in the National Coaching Camp is mandatory. Regional Centre/Head coach attached with the team is requested to ensure the facial attendance of all the campers.
 8. Travel sector Home – Camp – Back.
 9. Medical insurance to be done through SAI head Quarters, New Delhi.
