Election Report

IRFU ELECTION – RETURNING OFFICER'S REPORT

1. Introduction

This report ("**Report**") provides an overview of the activities undertaken by Shri Arvind Kamath, Senior Advocate, High Court of Karnataka, and Returning Officer, Indian Rugby Football Union ("**IRFU**") with respect to the conduct of the 2020 IRFU Election for the posts of President, Hon. Secretary and Hon. Treasurer ("**Election**").

2. Appointment of Returning Officer

The Returning Officer, IRFU was appointed by the Hon. Secretary, IRFU *vide* letter dated 8 December 2020 to oversee and supervise the election process for the posts of President, Hon. Secretary and Hon. Treasurer of the IRFU to be conducted on 30 December 2020, as scheduled and notified in the notice of Annual General Meeting dated 9 December 2020. The Returning Officer, IRFU was appointed in accordance with Section 5 of the Model Election Guidelines to be followed by all National Sports Federations as prescribed by the Ministry of Youth Affairs & Sports ("**MYAS**") under Annexure XXXVII of the National Sports Development Code of India, 2011 ("**Guidelines**").

3. Role of Returning Officer

The Returning Officer, IRFU's remit included the following:

- i) Scrutiny of electoral rolls, including all nominations and candidatures in the Election;
- ii) Adjudicating or deciding on any dispute or objection as to the candidacy, disqualification, eligibility to vote, or the admission or rejection of a vote with respect to the Election; and
- iii) Overseeing the voting, counting and declaration of results of the Election.

The Returning Officer, IRFU used his professional email id <u>akamath@almtlegal.com</u> for all inward and outward official communication relating to the Election. A dedicated page of the official IRFU website was created for all notifications and announcements in relation to the Election. The law firm LawNK was engaged by IRFU to provide legal assistance and also to provide secretarial support to the Returning Officer, IRFU until the completion of the Election. The Returning Officer, IRFU was also assisted by Mr. Souvik Paul Mazumdar, Partner, ALMT Legal.

4. Background to Election

The Election was conducted on the directions of the MYAS in its letter F. No. 33-1 / 2020- SP-III, dated – 26.11.2020, Subject – '*Renewal of recognition of Indian Rugby Football Union – reg*' ("**Renewal Letter**") whereby the IRFU was advised to conduct its election in accordance with the Guidelines to maintain IRFU's annual recognition as a 'National Sports Federation' by MYAS. Accordingly, the IRFU Board, at its Meeting on 28 November 2020 and continued on 1 December 2020, resolved to conduct fresh election of office bearers of the IRFU.

The Election was overseen and supervised by the Returning Officer, IRFU in accordance with: (a) relevant provisions of the IRFU Memorandum of Association, IRFU Articles of Association, National Sports Development Code of India, 2011 (incl. the Guidelines), and notifications/directions issued by MYAS or the Indian Olympic Association, as and to the extent applicable to the Election, as consolidated in <u>Annexure 1</u> hereto; and (b) the requirements specified under the IRFU Elections Rules of Procedure, as issued by the Returning Officer, IRFU ("Election Rules") and as specified in <u>Annexure 2</u> hereto;

On 9 December 2020, the Hon. Secretary, IRFU notified IRFU's members that the Election for the posts of President, Hon. Secretary and Hon. Treasurer would be conducted on 30 December 2020, during the Eighteenth Annual General Meeting ("AGM") of the IRFU. As per the Guidelines, the members were requested to provide in writing a list of their respective Member Representatives (as defined herein) who would constitute the Electoral College List and be eligible to vote and contest in the Election.

In the wake of the COVID-19 pandemic, IRFU was granted leave by the MYAS with reference to Circular – 'Sub – Holding of General Body Meetings and Elections of NSFs in the wake of COVID-19 pandemic, Ref. – F. No. 8-32 / 2020 / SP-III, Dated – 06.11.2020', reproduced under Annexure 2 hereto, to conduct the Election through digital / virtual platforms. Accordingly, the Returning Officer, IRFU conducted the Election in virtual format in accordance with the following schedule:

5. Nomination of Representatives

The Electoral College List specified under <u>Annexure 2</u> hereto includes the names of the representatives of the Permanent Members and Patron Members ("Member Representatives") nominated by the following Members to participate in the Election:

1. Article 7 of the IRFU Articles of Association which provides that the IRFU shall have only two (2) Patron Members - The Bombay Gymkhana Limited, Mumbai and The Calcutta Cricket and Football Club Limited, Kolkata (Calcutta);

2. Article 8 (i) of the IRFU Articles of Association which provides that the IRFU shall have five (5) Permanent Members, i.e., from each of the following zones and which are currently represented by -

- North Zone: North Zone Rugby Association (NZRA);
- South Zone: South India Rugby Football Association (SIRFA);
- East Zone: East India Rugby Football Union (EIRFU);
- West Zone: West India Rugby Football Union (WIRFU),
- Central Zone: Central India Rugby Football Association (CIRFA)

The Returning Officer was informed and was satisfied that the aforesaid 2 (two) Patron Members and 5 (five) Permanent Members constituted the entire membership of the IRFU as of date.

In accordance with the guidance provided under Paragraph 4 of the Guidelines, (i) each Permanent Member of the IRFU was invited to nominate 2 (two) Member Representatives, with 1 (one) vote granted to each such Member Representative, to participate in the Election and (ii) each Patron Member of the IRFU, as an institutional member, was invited to nominate 1 (one) Member Representative with 1 (one) vote granted to each such Member Representative.

A total of 12 (twelve) Member Representatives were duly included in the Electoral College List for the Election *vide* letter dated 11 December 2020 received by the Returning Officer, IRFU from the Hon. Secretary, IRFU. The Electoral College List was published on the IRFU website and no objections were raised with respect to the same.

6. Nomination Applications for Contesting Candidates

Pursuant to the release of the Electoral College List, the Returning Officer, IRFU invited any interested candidates to file nominations for a maximum of one (1) post each in the Election. Only individuals included in the Electoral College List were permitted to file nomination applications in accordance with the Election Rules and each nomination application was to be supported by a proposer and seconder from among those in the Electoral College List.

Upon the completion of the last date for submitting nomination applications, the Returning Officer, IRFU had received nomination applications from a total of 3 (three) candidates. There was 1 (one) nomination for each post that was in contention during the Election, i.e, President, Hon. Secretary and Hon. Treasurer.

Upon scrutiny of the nomination applications, which was conducted via video call with each candidate and their proposer and seconder at 12 pm on Sunday, 20 December 2020, all 3 (three) candidates were deemed eligible by the Returning Officer, IRFU to contest for the post for which they had filed nomination applications and the names of all 3 (three) candidates were included and published in the initial Nomination list.

The Returning Officer, IRFU did not receive any withdrawal application pursuant to the release of the initial Nomination List, and the names of all 3 (three) candidates were consequently included in the Final Nomination List for the Election, as reproduced in <u>Annexure 2</u>.

7. Observers and Invitees

The following persons attended the AGM in respect of the Election.

a) Mr. Arvind Kamath, Returning Officer, IRFU.

- b) Mr. Ridzal Saat, Independent Observer, World Rugby.
- c) Dr. Malav Shroff, Independent Observer, Indian Olympic Association (appointed by Indian Olympic Association vide letter dated 22 December, 2020).
- d) Mr. Nandan Kamath, Mr. Roshan Gopalakrishna and Mr. Seshank Shekar Rayaprolu from LawNK, Legal Counsel to IRFU.

8. Election Results

As only 1 (one) candidate was contesting for each post that was up for election, the Returning Officer, IRFU, relying upon the guidance provided in Clause 9(1) of the Guidelines with respect to 'Uncontested Returns', determined that it would be unnecessary to conduct polling on 30 December 2020, the designated election day. Accordingly, during the IRFU AGM conducted on 30 December 2020, the Returning Officer, IRFU declared the results of the Election and issued the List of Elected Candidates to the 3 (three) posts.

The following candidates were thereby declared duly elected at the IRFU Elections 2020 as of 30 December 2020:

- a) President: Mr. Vikram Ahuja
- b) Hon. Secretary: Mr. Gerald Prabhu
- c) Hon. Treasurer: Ms. Sanaya Mehta

As per the resolution of the IRFU Board and the resolution passed by the members at the AGM and subject to applicable law, the Returning Officer, IRFU was informed that the successful candidates as aforementioned shall hold office for a period of one (1) year from the date of the Election or until the amendment of the IRFU's Constitution comes into effect and fresh elections are held thereunder, whichever is earlier.

9. Election Documentation

Over the course of the election process, several notifications, documents and guidelines were issued in relation to the Election. Such documentation in <u>Annexure 2</u> is listed below along with a brief summary of each document:

a. <u>Notification of Election to the MYAS and Request for Permission to conduct the AGM via</u> <u>virtual/digital platforms</u> – *Issued by Hon. Secy., IRFU on 8 December 2020*

The Hon. Secretary notified the MYAS of the conduct of the Election in pursuance of the MYAS directions in the Renewal Letter and requested MYAS to appoint an observer for the Election as well as requested permission to conduct the Annual General Meeting for the Election via virtual/digital platforms in light of the COVID-19 pandemic.

b. Notification of AGM – Issued by Hon. Secy., IRFU on 9 December 2020

The Hon. Secretary notified IRFU's members of the organisation of IRFU's eighteenth AGM and of the conduct of the Election at such AGM in pursuance of the MYAS directions.

c. Letter to Permanent Members and Patron Members – Issued by Hon. Secy., IRFU on 10 December 2020

The Hon. Secretary notified IRFU's members to nominate their member representatives who would form part of the Electoral College List and vote at the Election.

d. <u>Electoral College List</u> - Issued by Hon. Secy., IRFU and approved by Returning Officer, IRFU on 11 December 2020

The Hon. Secretary notified the Returning Officer of the Electoral College List containing all IRFU Member Representatives entitled to participate in the Election. The Electoral College List as approved by the Returning Officer was also made available on the IRFU website.

e. <u>Letter of Notification of Election Schedule and Call to File Nomination Applications</u> – *Issued by Returning Officer, IRFU on 14 December 2020*

The Returning Officer, IRFU issued a letter notifying all IRFU Members of his appointment in pursuance of IRFU conducting election of its office bearers in compliance with the MYAS directions. The letter also included the Election Schedule and Rules of Procedure issued by the Returning Officer, IRFU for the conduct of the virtual Election.

f. List of Nominated Candidates - Issued by Returning Officer, IRFU on 18 December 2020

This notification listed out the names of all candidates who filed nomination applications for candidature in the Election, prior to scrutiny by the Returning Officer, IRFU.

g. <u>Election Scrutiny Communication</u> – Issued by the Returning Officer, IRFU on 19 December 2020

The Returning Officer, IRFU issued a corrigendum notification concerning the scrutiny of the Nominated Candidates for the Election which was scheduled to take place on 19 December 2020 but due to unavoidable circumstances was postponed to 20 December 2020.

h. <u>List of Validly Nominated Candidates to Contest in the Election</u> – *Issued by the Returning Officer, IRFU on 24 December 2020*

The Returning Officer, IRFU scrutinised the nomination applications for candidature and issued this final list which specified the names of validly nominated candidates in the Election.

i. <u>Declaration of Results of the Election</u> – *Issued by the Returning Officer, IRFU on 30 December* 2020

This notification declared the results of the Election and was issued by the Returning Officer, IRFU pursuant to the completion of IRFU Annual General Meeting held on 30 December 2020.

10. Conclusion

The Returning Officer, IRFU would like to conclude by placing on record his thanks and appreciation to the IRFU CEO, and to the legal advisors of the IRFU for assistance and support to the Returning Officer, IRFU in the course of carrying out his duties and responsibilities for the Election.

ANNEXURE 1

PROVISIONS AND NOTIFICATIONS RELEVANT TO IRFU ELECTIONS

I. Provisions from IRFU Articles of Association Dealing with Elections

MEMBERSHIP OF IRFU:

5. Membership of IRFU shall be confined to the following three (3) classes of Members only :-

- (a) Founder Members;
- (b) Patron Members; and,
- (c) Permanent Members.

6 The Founder Members shall the subscribers to this Memorandum and Articles of Association and shall automatically retire at the first annual general meeting as specified in Article 66 herein subject to compliance of the provisions of Companies Act, 1956.

7. The Patron Members shall always be The Bombay Gymkhana Limited, Mumbai and The Calcutta Cricket and Football Club Limited, Kolkata (Calcutta).

* 8. The following shall be Permanent Members :-

(a) one from each of the following Zones, who shall, on prior written permission and direction of IRFU, form and register/incorporate (as soon as possible after the incorporation of IRFU), a legal body/ entity (by whatever name called), each whereof shall be the sole controlling authority (subject to Article 3 herein) for its Zone (save and except for the Patron Members and the Indian Army), in respect of the conduct of Rugby- Football :-

- (i) North Zone;
- (ii) South Zone;
- (iii) East Zone;
- (iv) West Zone; and,
- (v) Central Zone.

VOTING RIGHTS, ATTENDANCE AND PARTICIPATION AT MEETINGS :

23. Every Member shall have one vote.

24. All Members shall be eligible to attend, participate and vote in the meetings of IRFU through one Representative only.

25. No Member shall have the right to vote at the Annual or any other meeting of IRFU or to be elected to the Board, the Managing Committee or any Sub-Committee unless such Member 's annual subscription and other dues (specified in Articles 18 to 22 herein) have been received by IRFU 15 (fifteen) days prior to such meeting/s and/or election/s provided that a notice in writing has been given to such member before 31st July to pay the Annual Subscription and the other dues.

* ELECTION OF THE BOARD OF DIRECTORS :

33. Subject to the provisions of Articles 34 and 35, the Board shall be elected every 4 years at an annual general meeting of IRFU.

34. The President, Honorary Treasurer or Honorary Secretary shall be elected every 4 years at a meeting of the Board (in accordance with Article 35), from amongst the Members and/or from amongst the persons specified in Article 38 herein.

* Altered pursuant to special resolution passed by the share holders of the company at their meeting held on 4th April, 2008.

35. No individual shall be eligible for re - election as President, Honorary Treasurer or Honorary Secretary for more than two consecutive terms (of 4 years each). Provided that :-

(a) an individual seeking re- election as President, Honorary Treasurer or Honorary Secretary for any further term which is not immediately following such individual's earlier two consecutive terms (of 4 years each), shall only be deemed to have been re - elected if he/ she secures a majority of not less than two thirds of the votes of the Board, failing which such individual shall be deemed to have lost the election, and the office shall be filled by election under the normal procedure from amongst individuals other than the individual seeking re - election; (b) no individual who has already held the office of President or Honorary Secretary or both for two consecutive terms (of 4 years each) shall be eligible to seek re- election as either President, Secretary, Vice President or Honorary Treasurer till the expiry of a period of at least four years from the date on which such individual last vacated the office of President or Honorary Secretary; and,

(c) no individual who has been the President, Honorary Secretary or Honorary Treasurer shall be eligible to be the President, Secretary /Secretary- General (or any corresponding office) or Treasurer, simultaneously, of any other National Sports Federation / Association, excepting the Indian Olympic Association.

36. All Directors (other than the President, Honorary Treasurer and Honorary Secretary) shall be elected : -

 (a) from amongst the Members and/ or from amongst the persons specified in Article 38 herein; and,

(b) every 4 years at a meeting of the Board and shall be eligible for reelection

37. All other Directors shall hold office from the date of election till the following meeting of the Board preceding the termination of their term.

38. The President and all other Directors may also be elected from any one or more of the following types of persons having the following qualifications: -

(a) all such persons shall be India n nationals; and,

(b) such persons shall have at least one of the following qualifications : -

(i) a past President of IRFU;

(ii) a Player who has played the game for at least ten (10) years at the national level;

 a person, who, in the opinion of the Board can contribute to the promotion and development of Rugby in India;

(iv) a practicing Solicitor and/or Advocate; or,

(v) a practicing Chartered Accountant.

II. <u>MYAS Notifications/Instructions Relevant to IRFU Elections</u>

a. National Sports Code of India, 2011

Organization (NSPO). AIU shall be eligible to receive government assistance at par with NSFs in "priority" category. Government has the right of recognizing other bodies doing commendable work in sports development at the national level as NSPOs.

9.3 Further in order to be eligible for assistance and continuing the recognition of Government the national sporting organizations must meet the following criteria/provisions:

- Follow proper, democratic and healthy management practices which provide for greater accountability and transparency at all levels.
- Maintain the recognition of the International Federation, Asian Federation, and IOA wherever applicable.
- iii. Adhere to Limits on duration of tenure of office bearers of Indian Olympic Association and all recognized National Sports Federations as notified vide letter No.F.8-17/2009-SP-III dated 01.05.2010. (Annexure-XIII)
- iv. Follow Guidelines on Good governance in the context of 'Basic Universal Principle of Good Governance of Olympic and Sports Movement' as issued vide Letter No.8-17/2009-SP-III dated 17.05.2010. (Annexure-XIV)
- Adopt proper accounting procedures at all levels and produce annual financial statements,
- vi. Adopt impartial and transparent selection procedures.
- vii. Provide a positive exposure to the Department of Youth Affairs and Sports as a major sponsor of sport in India.
- viii. Ensure that the dope tests of all its players are conducted regularly as per norms/ standards laid by the International Federation of the concerned discipline, National Anti-Doping Code notified vide gazette notification no 21-4/2008-ID dated 5th Feb, 2010 and detailed guidelines issued in this regard vide No.F.49-3-/2008-SP-II dated 18.09.2008 and letter No.9.19/2009-SP-II dated 30.10.2009. (Annexure-XX)
- Take measures against age fraud in Sports as indicated in letter No.F.32-18/209-SP-III dated 25.11.2009. (Annexure-XVI)
- x. Comply with the provisions of Right to Information Act and orders issued vide letter No.36-2/2010-SP-II dated 21.04.2010 and 30.3.2010. (Annexure XVIII)
- xi. Hold of regular national championships in all categories both

for men and women.

- xii. Include of sportspersons (say 25%) with voting rights in the management of NSFs
- xiii. Hold the elections as per Model election guidelines. (Annexure-XXXVII)

 - (b) 'Managing members' means Member of Managing Committee of

 - (d) _____ means Name of the Federation ;
 - (e) 'Post' includes the office of President, Secretary General, Treasurer, Vice President, Joint Secretary and Member of Managing Committee of ______.
 - (f) 'Rule' means the rule of Rules and Regulations of

2. Managing Committee:

(1) <u>The 7 (Seven) Officer Bearers (in addition to 5 executive members)</u> shall be as follows:-

1	President	1 (one)
2	Vice-Presidents	2 (2)
3	General Secretary	1 (one)
4	Treasurer	1 (one)

5 Joint Secretaries 2 (four)

(Note the above number may be changed according to the Constitution of the concerned Federation)

Manner of Election:

 Office Bearers and members of Managing Committee of _____ shall be elected by secret ballot.

(2) Election shall be held at the <u>Annual General Council Meeting (AGM)</u> in accordance with the procedure prescribed hereinafter, from amongst the

representatives of the Territories/Boards/Institutions. Permanent Member

States/Union

4. Electoral College:

(1) Each Permanent Member State/Union Territory duly affiliated by (abbreviation of Federation) as its Permanent Member shall have two votes at the elections of the Office Bearers and Managing Committee Members.

(2) For the purposes of sub-clause (1), each Permanent Member State/Union Territory shall be represented by <u>two members</u> authorised by the President or Secretary General/Secretary of the affiliated Permanent Member State/Union Territory; however, in case President/Secretary General / Secretary nominates different person(s), the person(s) authorised by the President shall be deemed to be the duly authorised person(s). Irrespective of the date.

(3) <u>Each Board or Institution duly affiliated by as its</u> <u>Permanent member under shall be represented by only</u> <u>one representative.</u>

(4) Each Permanent Member State/Union Territory and each Permanent Member Board/Institution shall intimate the name(s) of their representative(s) mentioned in sub-clauses (2) and (3), latest by _____ (Day - 1 - e.g. 13th December, 2040); and such intimation shall be addressed to the President / Secretary General of ______ on their letter head duly signed by President / Secretary General / Secretary of that member unit, so as to reach him on or before the aforesaid_date; any change in the name of any authorized representative after ______ (Day - 1 e.g. 13th December, 2010) or any intimation received thereafter shall be permitted only with the approval of the President of

(5) The President / Secretary General of ______ shall prepare the list of the authorised representatives of the Member States/Union Territories /Boards/ Institutions in Form 1, and circulate a copy of the list so prepared by him to all Member States/Union Territories/Boards/Institutions, latest by _____ (Day – 2 - e.g. 14th December, 2010), by display, on the website of _____.

(6) The President / Secretary General shall also furnish a duly authenticated copy of the list mentioned in sub-clause (5) to the Returning Officer as soon as may be after his appointment by the President of _____under clause (5) below.

5. Returning Officer:

As soon as may be before/after the issue of the Notice for the Annual General Meeting (AGM), the President of ______ shall nominate a person as Returning Officer for conduct of Election of Office Bearers and members of

 Managing Committee _____, in accordance with the provisions of these Byelaws.

6. Nomination of Candidates:

(1) The nomination of a candidate for election as Office Bearer or Member of the Managing Committee shall be made in **Form 2**.

(2) The nomination of a candidate for election as Office Bearer or a Member of Managing Committee shall be proposed by one of the representatives of Member States/Union Territories/Boards/Institutions whose name is included in the Electoral College list in Form 1, and also subscribed by 1 (one) such representative as seconder.

(3) Each candidate shall be entitled to be nominated by not more than 2 (two) nomination papers.

(4) Each Nomination Paper Shall be Delivered Personally to the Returning Officer in Person by the candidate himself/herself from _____ (Day - 3 e.g. <u>15th December, 2010</u> to _____ (Day-5 e.g <u>17th December, 2010</u>) between <u>11.00 AM</u> and <u>1.00 PM.</u>

(5) No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder; and, if he so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.

(6) No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been delivered to Returning Officer.

(7) As soon as may be after 1:00 P.M. on _____ (Day - 7 e.g. 19th December, 2010), the Returning Officer shall prepare a list of all nominations received by him, post wise, in Form 3; and publish the same in a conspicuous place in his office.

7. Scrutiny of Nominations:

(1) On _____ (Day-8 e.g. 20th December, 2010), at 11:00 A.M., The Returning Officer in his Office shall scrutinize each nomination paper, one by one, received by him, and determine its validity or otherwise.

(2) At the scrutiny of nominations, each candidate or one of his/her authorised representative shall have the right to be present and raise any objection in relation to nomination of a candidate for the post for which he/she has filed his/her nomination.

(3) As soon as may be after the scrutiny of all nomination papers has been completed by him, the Returning Officer shall prepare a list of validly nominated candidates in Form 4. And the Contesting Candidates can take a copy from the Returning Officer.

Withdrawal of candidatures:

 Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his/her candidature, from ______ (Day -8 e.g. 20th December, 2010) to upto 1:00 P.M. of ______ (Day-10 e.g. 22nd December, 2010).

(2) Notice of withdrawal of candidature shall be submitted in Form 5, either by the candidate himself/herself or by a person duly authorised by him/her in writing.

(3) Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.

(4) The Returning Officer shall accept the notice of withdrawal if he is satisfied as to the genuineness of the notice.

(5) As soon as may be after 11:00 AM on the ______ (Day 11 e.g. 23rd December, 2010), the Returning Officer shall prepare the final list of contesting candidates in Form 6, display a copy of the said list in conspicuous place in his office and on Federation's Website. And also furnish a copy of the same to each of the candidates/their authorised representatives, if they so demand.

(6) The names of the contesting candidates in Form 6 shall be arranged, for each post, in alphabetical order according to English alphabets:

Uncontested Returns; and Contested Elections

(1) Where the number of contesting candidates for any post or category of post, in **Form 6** is equal to the number of posts to be filled, all such contesting candidates shall be deemed to be duly elected unopposed to those posts, and it shall not be necessary to take a poll for election to such post.

(2) Where the number of contesting candidates for any post or category of post, in Form 6 is more than the number of posts to be filled, a poll shall be taken by secret ballot for those posts remaining unfilled.

(3) The ballot papers for these posts remaining unfilled shall be in Form 7 to Form 13 to be made individually for each post.

(4) The names of contesting candidates on the ballot papers shall appear in the same order as in Form 6.

10. Poll:

The Poll for the Posts Remaining Unfilled under clause 9(2) above shall (Day 16 - e.g. 28th December, 2010) and (1) shall commence at During The AGM at the Agenda Item Elections, in (Venue of the elections)

Each contesting candidate can nominate one person, (If he/ she so desires), Only from amongst the Authorised Representatives list of PCI, to be present at the Poll (Polling station).

At the poll, each authorised representative of Member States/Union Territories/Boards/Institutions, whose name is included in the Electoral College list in Form 1, shall be entitled to -

- cast one vote for each of the posts remaining unfilled, where only (i)
- one such seat is to be filled; cast as many votes as are the no. of seats to be filled for any post, (ii)

where more than one seat is to be filled.

Explanation: It is hereby clarified that for the purpose of filling four seats of Vice-Presidents, each voter can cast upto four votes, and, like-wise, for four seats of Joint Secretaries, and five seats of Members of Managing Committee, he/she can cast four and five votes respectively for the above mentioned four seats of Joint Secretaries and five seats of Members of Managing Committee.

In case any voter casts his/her vote for more than one candidate, or for more than four or five candidates, as the case may be, his/her vote for that post shall be invalid.

Each voter shall be required, before he is supplied with a Ballot paper, to give his/her signature on the authenticated copy of the Electoral College list in Form 1 used by the Returning Officer for taking the poll.

The voter shall record his/her vote on the ballot paper in secrecy in a voting compartment specially provided for the purpose at the polling station. (6)

The voter shall record his/her vote on the ballot paper by placing a tick mark (1) against the name of the candidate of his/her choice, and any other mark, like (x) etc. or word, placed on the ballot paper by him/her shall render the ballot paper liable to rejection.

The tick mark ($\sqrt{}$) to indicate the vote shall be placed by the voter only by means of article specifically provided for the purpose by the Returning Officer, and a ballot paper marked otherwise by means of any pen, ball point pen, etc. by the voter shall render the ballot paper liable to rejection.

The ballot paper marked by a voter shall be deposited by him/her in a ballot box specially prepared and sealed by the Returning Officer and placed at such a conspicuous place in the polling station that it shall be constantly visible to all present in the polling station.

(10) The Returning Officer shall close the poll at the appointed hour; however, all those voters who are present at the polling station at the appointed closing hour shall be entitled to vote even if the poll proceedings have to be continued for some more time.

(11) After all the voters referred to in sub-clause (9) have voted, the Returning Officer shall close the ballot box and shall not permit thereafter any person to vote.

(12) Polling will be done in below order:

(1) President

(2) Secretary General/General Secretary

- (3) Treasurer
- (4) Vice-Presidents
- (5) Joint-Secretaries

11. Counting of Votes:

(1) The Returning Officer shall take up the counting of votes as soon as may be after the polling for any post is complete.

(2) Each contesting candidate can nomininate one authorised representative (as clarified in S. No. 10 (2)) and He/She shall be entitled to be present at the place of counting of votes.

(3) The Returning Officer shall take up the counting of votes, post-wise and category wise, where applicable.

(4) Each ballot paper on which a vote has been recorded in accordance with sub-clauses (3) to (8) of clause (10) shall be treated as one vote for thecandidate for whom it has been validly marked; and if any ballot paper has been marked in violation of any of the aforesaid provisions of sub-clauses (3) to (8) of clause (10) shall be rejected by the Returning Officer.

(5) The votes validly cast for each of the contesting candidates shall be counted post-wise, and category-wise where applicable, and recorded in the descending order of the votes so cast for each candidate in **Form 14**.

(6) The Returning Officer shall thereafter ascertain the result of counting and, subject to the provisions of Rule 4 (a) (II) of the Rules, the candidates who have secured the maximum no. of votes in the said descending order, post-wise and category wise, where applicable, equal to the no. of seats to be filled for each post or category of posts, where applicable, shall be deemed to have been duly elected to those posts.

12. Declaration of Results:

The names of contesting candidates who shall be deemed to have been elected at the election in accordance with sub-clause (6) of clause (11) shall be declared as having been duly elected to their respective posts, by the Returning Officer at the Annual General Meeting (AGM) in the Form 15.

Subject: Renewal of recognition of Indian Rugby Football Union - reg.

Sir,

The matter regarding renewal of recognition to Indian Rugby Football Union has been examined. Indian Rugby Football Union's letter dated 25/10/2019 has been examined vide which Indian Rugby Football Union (IRFU) has informed that IRFU has nominated new Office Bearers in the AGM/BOD meeting held on 28/09/2019, Kolkata to hold the office till next election. It is informed that the nominated Office Bearers cannot be taken on record as they are not in accordance with the Model Election Guidelines under National Sports Development Code of India, 2011 hence IRFU is advised to conduct fresh election for the office bearers as per Model Election Guidelines under National Sports Development Code of India, 2011.

2. The matter regarding elections of NSFs which have not been conducted during the country-wide lockdown imposed to contain the spread of COVID-19 pandemic have been looked into by the Ministry. The restrictions imposed are being relaxed in phased manner by re-opening of activities outside the containment zone. Also under the latest guidelines issued by Ministry of Home Affairs social/academic/sports/entertainment/cultural/religious/political functions and other congregations have been permitted with a ceiling of 100 persons. However, directives for COVID-19 management are to be followed mandatorily. In the circumstances, it has been decided that Indian Rugby Football Union shall conduct election of its executive body by 31.12.2020, following the Model Elections guidelines prescribed in the National Sports Development Code 2011.

 Upon consideration of the entire matter, it has also been decided to renew the recognition of Indian Rugby Football Union up to 31.12.2020.

4. It has been noticed that constitution / MoA of the Indian Rugby Football Union needs to be aligned with the provisions of the National Sports Development Code of India, 2011 (Sports Code). Accordingly, the Indian Rugby Football Union is required to make categorical affirmation of the provisions of the Sports Code in its constitution <u>within 6 months</u> so as to bring the same fully in line with the Sports Code. The Federation is also required to take necessary steps for uploading of the information in compliance to the instructions as

contained in this Ministry's letter no. 9-7/2014-SP.I dated 26.02.2015 on suo-moto disclosure within 3 months' time (copy enclosed).

Sub: Information to be hoisted mandatorily by IOA & NSFs on their website - reg.

Sir,

Reference is invited to this Ministry's letter No. 9-69/2009-SP.I dated 29th November, 2010 and letter No. 8-20/2014-SP-III dated 15th October, 2014 wherein IOA and NSFs were asked to furnish the information to this office and to suo-moto disclose their various activities carried out by them. All these instructions have also been made part of the National Sports Development Code of India, 2011 (copies enclosed)

 It has been noticed that although some of the NSFs are furnishing the required information to this office, it is not available on the websites of many NSFs and hence is not available to general public and stake holders.

3. In a recent case of Badminton Association of India vs. Union of India, the Hon'ble High Court of Delhi has taken a serious view about non furnishing of information under RTI Act by the NSFs. Hence the court has passed an order dated 24th December, 2014 in W.P.(C) No.9318/2014 stating, inter-alia, that this would be an appropriate case where Government of India should examine the manner in which the NSF is functioning.

4. Therefore, in order to reduce the paper work of NSFs while making the information available to stakeholders regarding the functioning of NSFs and IOA it has been decided that henceforth the information as per the enclosed list shall be uploaded on the website of IOA and the respective NSFs.

All these information should be made available on the website latest by 1.4.2015.
 Further, the website must be updated by IOA & NSFs as frequently as possible and atleast once in a fortnight.

6. Vide order No.8-20/2014-SP-III dated 15.10.2014 it was informed that the NSFs shall post their audited accounts and the Balance Sheet of the previous year by 30th June of the current year. It was brought to the notice of this Ministry that finalisation of audited

accounts and balance sheet takes time and it is not possible to post the same on the website by 30th June. In view of this, it has been decided that the annual accounts of the previous financial year should be posted by the IOA & NSFs during the current year as soon as it is finalised but latest by 31st December of the current year.

 Consolidated list of information to be uploaded on the website of IOA & NSFs is enclosed.

 It is also informed that annual recognition for the year 2015 may be reviewed in case the above instructions are not complied with by 1.4. 2015.

ANNEXURE 2

RULES OF PROCEDURE FOR THE IRFU ELECTION

A. Electoral College List:

- The Electoral College List provided in Annexure 1 has been notified to the Returning Officer by the Hon. Secretary, IRFU vide the letter dated 11 December 2020.
- The Electoral College List includes the names of the representatives of the Permanent Members and Patron Members ("Member Representatives") nominated by such Members to participate in the IRFU Election,
- 3. In accordance with the guidance provided under Paragraph 4 of the Model Election Guidelines, each Permanent Member has been invited to nominate two (2) Member Representatives, with one (1) vote granted to each such Member Representative, to participate in the IRFU Election and each Patron Member has been invited to nominate one (1) Member Representative with one (1) vote granted to each such Member Representative.

B. Nomination of Candidates:

- Only Member Representatives included in the Electoral College List shall be eligible to file nominations for any post for which election is being held. Each Member representative shall be entitled to contest election for a single post only.
- The nomination application of a candidate for election as President, Hon. Secretary or Hon. Treasurer, shall be made as follows:
 - a) The nomination of candidate for election shall be proposed by one of the Member Representatives using Form 1 attached herewith;
 - b) Such nomination shall be seconded by 1 (one) other Member Representative as seconder using Form 2 attached herewith;
 - c) The candidate so proposed and seconded shall provide a declaration accepting such nomination as per Form 3 attached herewith.
- 3. Each of the nomination papers specified in Paragraph 2 above shall be notarized and scanned copies of all such nomination papers are required to be compiled and sent by the candidate via email using the contact details specified hereinbelow, to the Returning Officer before 1:00 PM on 17 December 2020. The candidate is also required to provide email confirmation from the proposer and seconder of their respective nomination papers within the aforementioned deadline. Originals of all nomination papers are required to be sent in sealed envelopes (and proposers and seconders may

send their papers separately from the nominee, if necessary), to the address specified below and are required to reach such address before 5:00 PM on 18 December 2020

- 4. No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder; and, if he so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.
- No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been delivered to the Returning Officer.
- On the appointed date as specified in the Election Schedule, the Returning Officer shall prepare a list of all nominations received by him, post wise, in and publish the same on the official website of the IRFU.

C. Scrutiny of Nominations:

- On the appointed date specified in the Election Schedule, the Returning Officer shall scrutinize each nomination paper, one by one, received by him, and determine its validity or otherwise.
- At the scrutiny of nominations, each candidate or one of his/her authorized representative shall have the right to be present via video conferencing and raise any objection in relation to nomination of a candidate for the post for which he/she has failed his/her nomination.
- 3. As soon as may be after the scrutiny of all nomination papers has been completed by him, the Returning Officer shall prepare a List of Validly Nominated Candidates and cause such list to be published on the IRFU website. The contesting candidates can also take a copy of such list from the Returning Officer.

D. Withdrawal of Candidatures:

- Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his/her candidature in accordance with the timelines prescribed in the Election Schedule.
- Notice of withdrawal of candidature shall be submitted in Form 4 attached herewith either by the candidate himself/herself by email to the Returning Officer.
- Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.
- The Returning Officer shall accept the notice of withdrawal if he is satisfied as to the genuineness of the notice.
- 5. In accordance with the timelines prescribed in the Election Schedule, the Returning Officer shall prepare the Final List of Contesting Candidates and display a copy of the said list on the IRFU's website, and also furnish a copy of the same to each of the candidates/their authorized representatives, if they so demand.

E. Uncontested Returns; and Contested Elections:

- Where the number of contesting candidates for any post or category of post, in the Final List of Contesting Candidates is equal to the number of posts to be filled, all such contesting candidates shall be deemed to be duly elected unopposed to those posts, and it shall not be necessary to take a poll for election to such post.
- Where the number of contesting candidates for any post or category of post, in the Final List of Contesting Candidates is more than the number of posts to be filled, a poll shall be conducted for those posts remaining unfilled.

F. Poll:

- The Returning Officer shall cause arrangements to be made for e-voting by the Electoral College List members on the day of the IRFU Election as specified in the Election Schedule and will call the Electoral College List members to exercise their voting right in respect of each of the contested Posts.
- 2. Polling will be done in below order:
 - (a) President
 - (b) Hon. Secretary
 - (c) Hon. Treasurer

 The Returning Officer will prescribe all other procedures for the Electoral College List members to cast their vote, including the maintenance of secrecy of votes, the time limit for exercising the voting right, etc.

G. Counting of Votes:

 At the closure of the time prescribed for voting, the Electoral Officer shall cause the counting of the votes cast and announce the results in respect of each of the contested posts. The candidates who have secured the maximum number of votes for each post shall be deemed to have been duly elected to those posts.

H. Declaration of Results:

 The names of contesting candidates who shall be deemed to have been elected at the election in accordance with Rule (G) (1) shall be declared as having been duly elected to their respective posts by the Returning Officer at the Annual General Meeting (AGM) dated 30 December, 2020.

I. Disputes:
