1. Release of Rs. 1,49,002.48/- (Rupees One lakh forty-nine thousand two rupees and forty-eight paise Only) as 75% advance of Rs. 1,98,669.98 (Rupees One lakh ninety-eight thousand six hundred sixty-nine rupees and ninety-eight paise Only)
2. The purchase procedures as contained in General Financial Rules (GFRs) and CVC guidelines should be followed and certificate to this effect will be furnished by IRFU.
3. IRFU will allow scrutiny of the purchase by Government audit and follow CVC guidelines in its purchase.
4. A reasonable rate certificate that the items of the same specifications/ brand procured have not been supplied by any other Government / Semi Government /Private Organisation at a lesser rate, to be provided by IRFU from the supplier/agency.
5. IRFU will provide a certificate that these items would be used for training of athletes during National Coaching Camps.
6. The grantee shall not divert the grants and entrust execution of the scheme or work concerned to another institute of organization and shall abide by the terms and conditions of the grant. If the grantee fails to utilize the grant, for the purpose for which the same has been sanctioned, the grantee will be required to refund the entire amount with interest thereon @ 10% per annum, as per Rule 209(6).
7. The amount for reimbursement will be restricted to the actual expenditure incurred by IRFU on procurement.
8. Stock Entry of the Equipment will be made at concerned SAI centre and then will be issued to the IRFU for training purposes.
9. Provisions of General Financial Rules (GFR) to be followed for procurement. NSF will be required to submit Utilization Certificate duly certified by CAG empanelled C.A.
